I understand a donation is subject to RE-RIDE review and approval of this application. If this application is accepted I understand and agree to the following:

By delivery of the Donated Horse to RE-RIDE, I transfer complete ownership of the Donated Horse to RE-RIDE Quarter Horse Adoption Program, which includes the care, custody, and control of the animal, and the right to transfer ownership/registration to RE-RIDE or a person or organization adopting the Donated Horse. Horses with an appraised value of over \$5000 will remain in the programs ownership for a three year (3) period during which time the horses will be made available for lease to qualified adopters . RE-RIDE shall have sole and full discretion on the care and disposition of the horse, to include making decisions on veterinary treatment or procedures, adoption of the horse to persons or organizations deemed suitable by RE-RIDE, or euthanasia. RE-RIDE shall not be responsible for any fees, including boarding fees. RE-RIDE will not pay any fees to past providers, and Donor will indemnify and hold RE-RIDE harmless of any claim arising or lien asserted from such past care of Donated Horse.

Liability and Risk of Loss remains with Donor until RE-RIDE is in actual possession of the Donated Horse.

After acceptance of the delivery of the Donated Horse, RE-RIDE will provide me with a receipt acknowledging the possession of the animal. If you plan to take a tax deduction for the donation to RE-RIDE {a 501(c)3 charitable organization} you will need to arrange for the valuation of the animal before delivery to RE-RIDE . RE-RIDE is not able to provide an opinion on value.

All matters arising from this donation to RE-RIDE will be construed under the laws of the State of Ohio, and any action by either property shall be brought in a court of competent jurisdiction in Union County, Ohio.

This agreement contains the entire agreement of the parties and there are no promises, agreements, representations or warranties other than those contained herein or expressly incorporated by reference.
